#### Safety glasses

Use tightly fitting safety glasses as per Australian Standard AS 1336 and AS/NZS 1337.

#### Protective gloves

The glove material has to be impermeable and resistant to the product/ the substance/ the preparation.

Due to missing tests no recommendation to the glove material can be given for the product/ the preparation/ the chemical mixture.

Selection of the glove material on consideration of the penetration times, rates of diffusion and the degradation.

#### Material of gloves

Butyl rubber, BR.

Fluorocarbon rubber (Viton).

PVA gloves.
